#### 18 March 2022: Changes confirmed for Permanent Residency

New legislation provides opportunity of permanent residency for all sponsored (457 or 482 visa) workers who remained in Australia during the pandemic. This means that sponsored 457 or 482 visa holders with 'short-term' occupations – who remained in Australia during the pandemic – can access the employer nominated permanent residency (Subclass 186).

Australian businesses can nominate any (457 or 482 visa) sponsored employee for permanent residency if the employee was in Australia for at least 12 months between 1 February 2020 and 14 December 2021. The application can be made after the employee has worked with the same business on a sponsored visa for 3 years, or when the 3 years occurs.

Note: Applications can only be lodged from 1 July 2022.

### FAQ's

- Can you lodge from a Bridging Visa Status if still awaiting a current Visa to be processed: This depends on the new Visa being applied for
- Does time on a BVA processing between two 457/482 Visas held and still with the same company count towards the 3 years: YES
- You must have stayed in the same occupation.
- You must be employed by the same employer for the 3 years.
- Age limit is 45 at time of application.
- There are still further questions around if your 2 x 482 Visas expire before your eligibility and the industry body is seeking clarification around that.
- Time being "Stood Down" during COVID should not affect the eligibility.
